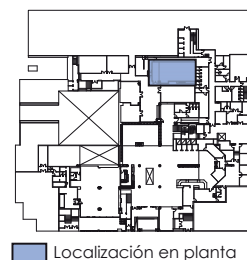
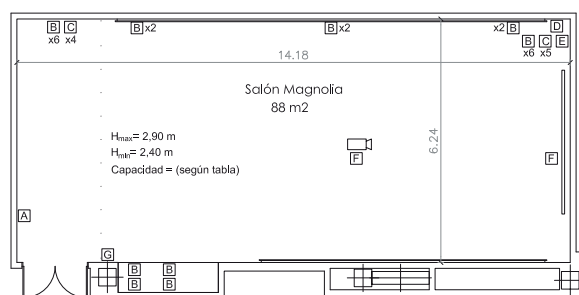

VENUE LAYOUT

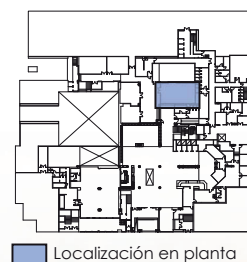
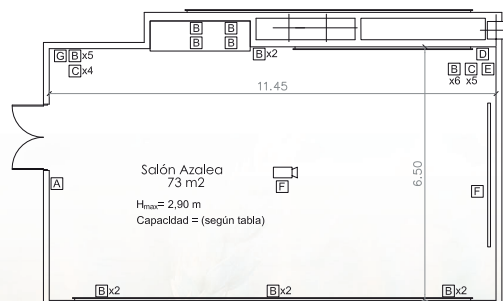

MAGNOLIA HALL MELIÁ SEVILLA



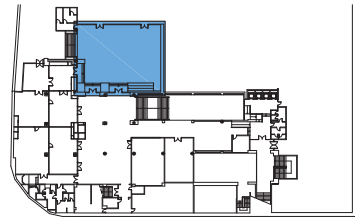
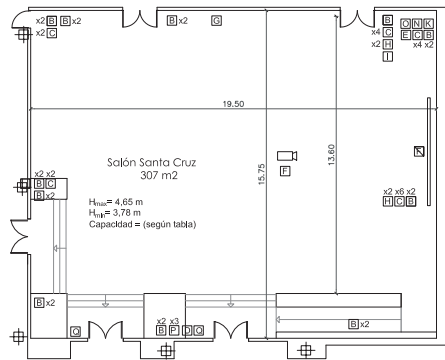

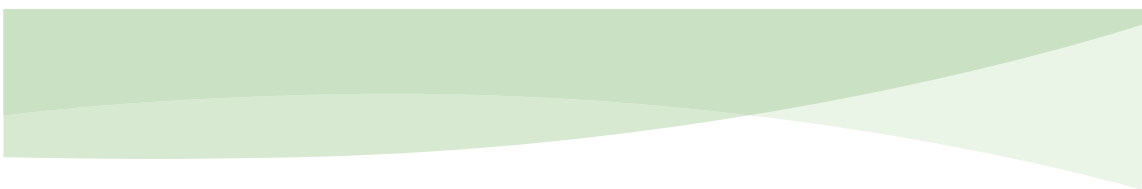
